## Are Some State Constitutional Marriage Bans More Restrictive Than Others?

- At the time this paper was written, no study had found, or been undertaken to find, an answer to this question.
- Traditional literature on direct democracy institutions would suggest, states which operate under direct democracy institutions that have constitutional marriage bans would be more restrictive than non-direct democracy institution states.
- There is also evidence to suggest that policies grounded in morals are more also restrictive of minority rights.

#### Data & Methods

- At the time this paper was written there were thirty-one states with constitutional marriage bans in the United States.
- A content analysis was employed to compare the constitutional marriage bans.

#### Results

- States in the Southern region of the U.S. have more restrictive constitutional marriage bans than other states.
- The were more moralistic constitutional marriage bans in the South, which can account for the restrictiveness.
- Surprisingly, the majority of Southern states operate under non-direct democracy institutions, which are supposed to be less restrictive of minority rights
